Offences & penalty procedure for traffic control.

• Limits of speed & loading limit of vehicle with respect to power to weight ratio

Limit of speed (MVA-5-112), (1) maximum speed, (2) Authority to control (3)

power to weight ratio: (MVA-5-114) → 10km

used to measure actual performance of engine or power source

$$= \frac{\text{Engine power out}}{\text{weight (mass of vehicle)}} \left[\begin{array}{l} \text{Thrust per unit mass} \\ \times \text{Velocity of vehicle} \end{array} \right]$$

Ex: Turbocharged V8 Diesel Engine

- Engine power: 250 kW [340 hp]

mass: 350 kg

$$= \frac{250}{350} = 0.65 \frac{\text{kW}}{\text{kg}} \quad 1 \text{ kW} = 1.34 \text{ hp}$$

Section: 4: No person under the age of 18 years shall drive a motor vehicle in public place 50 cc. / sixteen-year

• Taking part in unauthorized sale or trial of Speed
→ 1 महीने के अन्दर 300 रु. Fine

• Obtaining or applying for a license
without giving particulars of Endorsement
→ 3 महीने के अन्दर 500 रु. Fine
Section-182

• Failing to stop on the occurrence of accident
Section-131 → 500 रु. Fine अथवा 3 महीने के लिए
Section 132 → 1000 रु. Fine अथवा 6 महीने के लिए
